DR. JAMES EARL MASSEY

Tuskegee University

In a special issue of our "Meet the Minister" series, we are looking today at a minister who works not in a church but in a totally secular setting.

Dr. James Earl Massey is a Church of God (Anderson, IN) minister who is presently serving as Dean of the Chapel at Tuskegee University, as well as being the University Professor of Religion. He was on campus last week for the Staley Distinguished Christian Scholar Lecture series, and we took advantage of that time to get to know a little more about him.

One of five sons in a fourth generation Church of God family, James Massey grew up in the church and so felt safe to go elsewhere for his higher education. He said that he had been indoctrinated in the beliefs of his church, and wanted a broader experience (one that would seem to help him in his present position). He has attended the University of Detroit, Detroit Bible College (he received his B.A. from there, now William Tyndale College), Oberlin Graduate School of Theology (M.A.), the University of Michigan, Asbury Theological Seminary (Ph.D.),

Pacific School of Religion, and Boston College Graduate School.

Dr. Massey pastored Detroit's Metropolitan Church of God from 1954-1977. In that time he took a leave from 1963-6 to serve in the Church of God's school of theology in Kingston, Jamaica. As to the leave, Dr. Massey said that when he showed God he was willing to give up the church he had been used to build for God's will, he was allowed to keep it as well as do the Father's will in Jamaica.

Also, in 1969 he became campus minister of Anderson College in Anderson, IN., the denomination's main school. Upon appointment as the Church of God's speaker on its radio program, he resigned his duties at the church and Anderson College, although still teaching part time. Full-time teaching was finally embraced in December 1982, and the post at Tuskegee came in July of 1984.

Dr. Massey had about half of his college and graduate studies in Communications. He believes that "to be a great minister, you must be a great communicator." His speaking skill, which shone through in his Staley lectures, backs another of his admonitions.

Associated Student Body leadership: One word won't describe it all

Spring to many people denotes a time of change — a change of weather, a change of dress styles, and at Trevecca, a change in student leadership. What does it take to be a leader? Responsibility, commitment, dedication and courage were but a few of the one word descriptions given by student government leaders of the qualities necessary to be an effective leader.

This is the first of a two-part look at individual student government positions and what is deemed important by those who have served in one of these positions this past year. Part one will take a look at the Associated Student Body leaders, while part two will analyze the remainder of Student government.

The Associated Student Body officers to be looked at in this issue are the scholarship-bearing offices. Each ASB officer is a member of the Student Government Assembly which meets once a week during each term of the regular school year to discuss issues of student interest, plan various activities for

students, appoint other non-elected student leaders, and give reports from their various areas of responsibility. The majority of these offices are located on the top floor of the Jernigan Student Center save the two student publications, which are located on the ground floor of the building.

First on the list of officers must come the ASB President, a position of intense pressure, responsibility and public criticism. Also falling into this string of adjectives are clout, esteem and prestige. (Any words left out of the description probably will also fit.) Melinda Nabors currently holds this position. She sees the main responsibilities of her position as being a representative of students to faculty, administration and constituency (Board of Trustees); improving the morale of students; and "making sure everything gets done." The ASB President heads the SGA Executive Committee made up of the ASB President, Executive Vice-President, Executive Secretary, Executive Treasurer, and Attorney General. The purpose of this committee is to

decide what needs to be taken before the Assembly, including research and supervision of any projects undertaken. The ASB President works as a student representative to the Administrative Council, Institutional Planning Committee (Board of Trustees), Student Life Council (Board of Trustees), and other temporary committees such as the Fine Procedure Committee. Along with the office comes numerous other activities such as planning meetings, preside over SGA meetings, meet with the Board of Trustees, speak at various events sponsored by the college, communicate with the Dean of Students and President of the College on disciplinary measures and other issues relevant to students. As a place of service, Melinda feels that the priority should be, "students, faculty, adminsistrators, students." In summary, the qualifications for ASB President could be described as the, "Ability to put up with and work well with a busy schedule, possess organizational and communicative skills, have previous

namely that we use our giftedness in showing Christ to others. We each have different abilities, and God didn't make a mistake in calling us to his service.

Being Christ's minister would seem to be more difficult in a secular setting such as Tuskegee than in a church or at a Christian campus like TNC or Anderson. Dr. Massey considers it a challenge. "We have a whole generation that knows nothing about church culture." They cannot be reached, he said, with the words that we have grown up with to give meaning to our faith. Jesus met people where they were, and that's what we must do. "Don't deal with the church when talking to the sinner deal with Christ." Dr. Massey says he deals with "the hunger", the need in each of us that we can spend our lives trying to fill. He doesn't try to tell people they're wrong and must be saved, he shows them Christ and shows them that Christ can fill the hunger.

Also, all Christians should take part in filling the hunger. "There's a lot of human need, and it's been God's will to use human care to

meet human need."

That human need hasn't always been easy to meet though, especially when they don't accept you as human. In his forty years of ministry (he started in June of 1946), Dr. Massey was a participant in the civil rights fight in the 50's and 60's. "We knew it [the treatment of blacks] was wrong, and our generation decided we would rather die than accept it . . . we broke the law and accepted the punishment, instead of trying to run from it . . . there are times when you must follow a policy of non-cooperation with evil."

Dr. Massey doesn't though, believe that the church should participate in politics. He says the church has its responsibility as the moral guardian of the people, but that shouldn't be done through laws. His view is that we as Christians and Americans should participate in the political process, but that it is wrong in a democratic society to expect all of the politicians to agree with you on any one issue. The government was instituted by God to run societies, and in some cases, "I don't trust the church's judgement." To support this, Dr. Massey referred to the many times when a disagreement between the church and other parts of society ended up showing the church in error: planetary motion, slavery, even Nazism in some cases. He believes Jesus was talking about something besides just taxes when the savior mentioned rendering to Caesar what was Caesar's

Dr. Massey's idea of the church itself also causes discussion and thought, although it is similar to that proposed by other ministers and theologians. He says it comes from his background. "The black experience is very familiar with the extended family, and we consider the church like an extended family." Included in this metaphor are the responsibilities of families, such as his actions when faced with two people whom he didn't believe should be married. "I broke them up." He says he believes in church discipline. Referring to the recent case in which a court ordered a Church of Christ body to accept into membership again a member they had excommunicated, Dr. Massey said that that wouldn't happen at his church. "When you join a church ... you subscribe to a covenant," and that includes agreeing to abide by the rules of the body. The church is not everyone; it is Christ's body giving itself in His service. "The church must sound and continue to sound the note of service," meeting that hunger with Christ's love and mercy. He believes the hardest challenge in ministry is conveying to people your love for them, and that is therefore what we should work at the most.

He disagrees though, with those who believe we should expect people to accept Christianity for the feelings it brings. "The best feeling follows thought," coming from someone deciding what's best for them, receiving not just emotion but Christ in his fullness.

Christ in His fullness is what Dr. Massey preaches also. His messages in the Staley lectures dealt first with us knowing ourselves, secondly in knowing Christ in His fullness, and lastly in the integration of that and the place of the Spirit in the whole process. His experience and gifts showed through in the delivery and substance of each message, as it did in personal ministry. He is a very professional man, dedicated to his calling and to being all he can within that. His love for his Lord comes through, as does his love of his job. Once again the Staley series has brought an excellent speaker to our campus, motivating and equipping us to go ever high in His

Exercise can lower blood pressure

Aerobic exercise can control high blood pressure in some individuals, but to keep blood pressure at a normal level,

exercise must become a way of life.

"In certain individuals, aerobic exercise may be a viable alternative to medication," says behavioral psychologist John E. Martin, Ph. D., "especially if the high blood pressure is detected



However, Martin warns, there is a problem when people whose high blood ressure is lowered by exercise believe they are cured and quit exercising.
"They must realize that if they quit exercising, they need to take medication to maintain a normal blood pressure. And for some, it will take a small dose of medication in addition to exercise."

Aerobic exercise increases breathing and the blood flow to working muscles. Done for an extended amount of time it

can strengthen the heart, lungs and blood vessels. According to the American Heart Association, to be effective, aerobic exercise must be done for 15-30 minutes at least three times a week. The exercise must raise the heart rate to at least 65 percent of its maximum capacity. Exercising at too high an intensity can cause injuries or a burnout of moti-

can cause injuries or a burnout of moti-vation, Martin points out. Some common aerobic exercises are cycling, brisk walking, lap swimming, jogging, and aerobic dance. Martin has conducted research at the

Veterans Administration Medical Center in Jackson, Mississippi on the effects of exercise on blood pressure. "When effec-tive, behavioral methods of controlling high blood pressure (such as aerobic ex ercise) appear to have distinct advantages over medication alone," says Martin. High blood pressure medication can cause negative side effects, such as weakness or impotence. Behavioral methods can create positive side effects by making the patient feel better physically, he explains.

But, after a patient feels better, there tion to continue the aerobic exercise program. "Lack of symptoms encourages lack of compliance," Martin comments.

It is important to provide encourage ment so a patient will continue the exercise program. "It is easier to just take a pill than to exercise, so we need to stablish an 'effective comfort zone' Martin explains that an effective comfort zone is a level of exercise that patients can enjoy without huffing, puffing and turning red. Scientists who work with Martin encourage other family members to exercise with the patients to make it

as enjoyable an experience as possible.
All programs to control blood pressure through exercise must be done with medical supervision, Martin warns. Can-didates in his program are screened to find any previous heart, kidney or vas-

The price of the cups is approximately what the supplier charges me. It is built into the price of soft drinks and deducted from the price when refills are purchased. This policy is spelled out in our menu which has been circulated throughout the campus, is posted on the counter in the Snack Shoppe, and is readily available to anyone who cares to pick one up from the supply maintained on our counter.

If the minimum price of 5¢ is too great for the purchase of an "unsanitary container," I would suggest a paper sealed straw on which no charge is made be used.

As to the price of milk, I can only say if you find a better price for a 16 ounce carton, buy some for me too.

I will admit that Mr. Steenbergen may have me on his charge of being inconsistent. The dictionary defines "inconsistent" as "changable." Christ Himself was often accused of keeping "bad company," and of frequenting places where the untouchables of society were present; but the only thing of which He was guilty was putting to full use His ability to love what was unlovely. Amy Grant recorded a song called "Father's Eyes," and a part of the chorus says, ". . . eyes that found the good in things when good was not around. . ." And that is exactly what Christ did. He looked beyond the physical, beyond the things that mattered to the world, and He saw the real person: an individual formed by the Creator, with a divine purpose in life. That was easy for Him, you say? Well, it isn't out of our own reach, either. In Philippians 2:5-11, a familiar and favorite scripture, Paul shares with us this thought:

Your attitude should be the same as that of Christ Jesus: Who, being in the very nature of God, did not consider equality with God something to be grasped, but made Himself nothing, taking on the very nature of a servant, being made in human likeness. And being found in appearance as a man, He humbled Himself and became obedient to death—even death on a cross! Therefore, God exalted Him to the highest place and gave Him a name that is above every other name. . .

This attitude of Christ's was one of selfless, servant-like love. He saw the potential beauty in each one of us, and was willing to die so that we might reach that fullness of potential and become complete in

So often, I have to wonder what life would be like if Christ thought in the same way that some people think. I have to picture Him there on His throne, checklist in hand, saying, "Let's see . . . he's flunking those really easy basics—a real loser—I just won't associate with him anymore. . . and that girl! There is an art to loving, and when you base it on the right attitude, the picture you paint, and the feelings you create can be beautiful . . . to you and to God.

He feels that his responsibilities are to monitor the "legal" aspects of clubs on campus, and to coordinate Club Rush, Homecoming Parade, Super-Sub Committees, Awards Chapel, and take care of any correspondence concerning student life. The Vice-President heads the Student Life Committee and is a representative to the Administrative Council, the Calendar Committee, the Institutional Planning Committee, the Student Life Council, Community Living Council. The Vice-President also is a member of the SGA Executive Committee, SGA, Student Life Committee, and of CLC sub-committee. Brad feels that the qualifications for this position include being "a person who loves to have fun and work hard at the same time. Someone who can practice a lot of patience and deal with the frustrations of club quarterly report deadlines, someone who is not afraid to speak up when problems concerning student life come to his attention; someone who enjoys leadership, service and who can relate to people well."

Denise Franklin has been the 1986-86 ASB Executive Secretary. Her primary responsibility to her job requires keeping good records of minutes and attendance at SGA meetings and seeing that SGA members are kept up to date on developments that arise between meetings. The Secretary occasionally will be called on to head or co-head special committees such as the Berry School Committee, which oversees activities in the Adopt-a-school program established by the Metro Board of Education to afford underpriviledged children opportunities they might not otherwise have. The secretary is frequently

called on to do odd jobs that include "anything and everything." Denise feels that qualifications for the position of ASB Secretary include responsibility, some typing abilities, a *desire* to serve, good discipline of time for academics and social life, and a willingness to do "little" jobs to "help the big things go off."

Another member of the ASB Executive Committee is the ASB Treasurer. Jeff Alford, who now holds this office, feels the primary responsibilities are to head the Finance Committee, which allocates the total amount budgeted for Student Body classes, organizations, and committees, and to continually monitor and report on the accounts of the various student organizations. Other activities which come with this office include fund raising, paying bills, preparing statements, monitoring the SGA accounts, and working closely with the administration and the Business Office. Jeff believes qualifications for the job would include enjoying working with figures, having "patience" with balancing accounts, and preferably being a business major.

The last, but certainly not least, member of the Executive Committee is the ASB Attorney General. This position requires that one coordinate all elections, polls and votes of the student body. Currently in this position is Stephen Perry. Part of his job is to head the Election Affairs Committee and the Dorm Judiciary Committee, as well as being a member of the ASB Executive Committee, the Student Life Committee, and the Student Life Council. The Attorney General serves as the Parliamentarian of SGA. The office is busy with such things as Homecoming and Valentine's Court elections, ASB elections, SGA class elections, election survey polls, etc. Stephen considers the ability to court and organize, have some kind of knowledge of parliamentary procedures and voting procedures necessary qualifications for the office.

Functioning as a part of the Student Government Assembly are representatives of the four major concerns of this college: Religious Life, Academic Affairs, Social Life and Intramural Sports. These representatives are the Vice-President of Religious Life, Vice-President of Academic Affairs, Vice-President of Social Life and Vice-President of the Trevecca Intramural Association (TIA).

The office Vice-President of Religious Life is presently occupied by Claude Perhealth. He feels that the areas of responsibility are in serving as an assistant to organizing all the religious activities on campus and encouraging spiritual growth through personal involvement as well as personal devotional life. The Vice-President of Religious Life serves as head of the Religious Life Committee and as a member of the Chapel Committee. Claude is responsible for Spiritual Renewal Week, the Staley Lectures, Monday chapels, assisting all ministry directors when needed, and leading devotionals at SGA meetings. Qualifications for the position, Claude feels, are spiritual maturity, sensitivity to people's needs, organizational skills, personal "one-on-one" counseling skills, a servant attitude and the ability to truly love people and place their needs and concerns as a priority to be et.

The newest addition to the group of ASB officers is the office of Vice-President of Academic Life. The position is held by Becki Loar at this time. She feels her areas of responsibility lie in being a liaison between other major campus areas (SAC, RLC, SGA, etc.) and administrators and faculty. Becki works with the Academic Affairs Committee and in close connection with Trevecca's Honor Society. The Vice-President of Academic Affairs is also called on to serve on other committees such as the Academic Council, the Curriculum Committee and the Calendar Study Committee. There are also other activities which greatly occupy the Vice-President's time. Such activities as the Graduate Seminar, the Trevecca Trivia Tournament, Faculty Appreciation Day, Academic Excellence Chapel and Honors Banquet are among other duties of the office. To do the job, Becki feels there should be an "acquaintance with a wide cross-section of students — a discussion-based relationship with the students, faculty and administration."

One of the most visible ASB offices is that of Vice-President of Social Life. Scott Winchell currently holds this office. He feels the primary responsibility of the position entails planning and organizing student social activities (concerts, films, retreats, etc.). To help with the task, the Vice-President of Social Life has the Social Activities Committee. Other activities that come with the office, according to Scott include "anything under the sun." Scott feels a person should be able to relate to the mindset of most everyone. To do the job requires, "one who is crazy and can work under pressure."

The fourth, but every bit as important, office is that of Vice-President of the Trevecca Intramural Association (TIA). The purpose of this office is to coordinate and carry through campus sports and activities to get the students involved. The office is currently filled by Cara Patterson. She heads the TIA Council, and is on the Intercollegiate Athletic Board.

The Vice-President of TIA each quarter organizes different sports to encourage competition between the societies. TIA also sponsors tournaments and game nights in the Snack Shoppe. The Vice-President of TIA gets help from not only the TIA Council, but from a Men's Coordinator, a Women's Coordinator and the TIA Council Society Representatives. To work effectively in this capacity, one must have to want to work with students to see what they want. One must need an outgoing attitude and a desire to see people get involved. "Most of all," says Cara of her position, "we need someone who won't give up, but will work to get as many people involved as possible.

There are two major publications on campus which are student-run. The editors of these publications are elected by students as ASB officers. The publications are *Darda* and *Trev-Echoes*.

Darda, the school yearbook, is run by Beverli Lindsey. Beverli feels that the ideal responsibility of the Darda Editor is "to see that deadlines are met and that pictures are taken, copy written, etc. for the headlines." Beverli believes that the Editor should have previous experience working on a yearbook staff and posses a knowledge of every facet of the staff.

Trev-Echoes, the student newspaper, is run by Nathan Hyde. He



sees the primary responsibility of Editor as publishing Trev-Echoes at regular intervals, keeping students abreast of current events relating to college life. The Editor chairs the Trev-Echoes Executive Committee made up of subordinate editors and managers. As with all other ASB officers, the Editor is a member of the Student Life Council which meets at least each spring to revise and update the Student Handbook. The Trev-Echoes Editor is involved in SGA meetings, their related activities that occur during the year, and serves as Managing Editor for Legacy, the literary magazine sponsored by Trev-Echoes. Assisting the Editor on the multi-level staff are other editors, writers, managers, advertising sales personnel and office personnel. Nathan feels the Editor should have a working knowledge of advertising, budgeting, finances, basic writing skills, typesetting and printing industries, editing procedures and techniques, layout skills, equipment and supplies, student government functions and responsibilities, people skills (leadership of staff, public relations, business relations), and criteria set forth in the Student Handbook, Student Services policy guidelines and the Constitution of the Associated Student Body. Also, Scholastic Editor's Trends In Publications suggests looking for the following qualities:

• Authoritative — Editors need to be people who will be respected by the staff, who can make decisions (even the wrong ones), give assignments and take as well as give criticism.

• Critical — Editors must view the paper with a critical eye, have an opinion, and express it when the situation warrants.

• Sensitive — Although critical of the staff's work, editors must be sensitive — especially to the timing of the criticism. Sensitive editors will know when the entire staff is down and when a specific reporter has a problem, and will realize that a touch of understanding goes a long way in keeping a harmonious staff.

• Objectivity — If, as some think, objectivity is not in the realm of reality, then it must at least be an unwavering goal for editors.

• Enthusiastic — When the staff is dragging, editors must fire


them up. Editors must also review the direction of the paper, make necessary changes and implement innovations.

• Talented — While not necessarily the most talented staff members, editors need to be skilled enough to gain the respect of the staff and to do last-minute rewrites, cutlines, headlines and corrections.

• Humor — Editos must be able to laugh with others and at themselves. A sense of humor is also useful during rough times, long winters and the times when the world caves in an hour before deadline.

After this glance at the work-loads of ASB officers, it is a wonder how they maintain student status. However, there is an exhilarating moment or two that makes the whole experience worthwhile. If you are interested in any of these eleven positions, get in touch with the person holding the office soon. ASB elections are set for Monday, April 14 with SGA class elections set for Monday, April 28.

Look for part two on SGA class officers in the first Spring Quarter issue of *Trev-Echoes*.




Kenny Marks voiced his ideas about relationships in several songs as he provided the entertainment for the Valentine Banquet.

Albums show artists in new light

Three of the latest releases in Christian music show us some of the most popular artists in new lights. New releases out by Kenny Marks, the Bill Gaither Trio and Michael W. Smith remind us that change can be for the better, even

from good.

Kenny Marks's latest, Attitude (Dayspring, \$8.98), shows his same themes in new sounds and scenes. His emphasis on relationships is still strong, dealing with friendship, dating, marriage and success in a sound vastly improved from his earlier music. He has added an extra edge to his bluesy pop sound, with more guitar and drums in the music. The lyrics have an extra edge also, from the honest critique of society in "Heart Trouble" and "The Party's Over" to the hope and joy in "It's a Good Thing" and "Soul Reviver." "Heroes" and "Friends" will bring people to mind, and the whole album will help your image of how Christians relate to others.

The Bill Gaither Trio, now in their 26th year of ministry, are classical. So is their new album, Then He Said "Sing." The wholesome, happy, praise-filled pens of Bill and Gloria Gaither are given new life by the arrangements of their best songs using the latest equipment. It's a "Best Of" album, but the sound is alive and full of the joy they have represented for so long. Also included is the title cut, a celebration of God's gift of music, with vocals by Don Francisco, Amy Grant, Larnelle Harris and Sandi Patti. It alone is worth the album cost, and reminds you how much the Christian music community has been blessed, both directly and indirectly by them. The album is an enjoyable way to rediscover an excellent group.

The final entry is a videotape of Michael W. Smith's concert in Atlanta last spring (incidentally, he started as keyboardist for Amy Grant, who started warming up for the Gaithers). For anyone who was lucky enough to see the

Friends tour, this tape starts where K.T. finished. For those who didn't see the concert, this is your chance to find out why Michael is one of the most popular artists in the Christian music world. His excellent songwriting (he wrote or cowrote every song on the videotape) is paled by comparison with the performance and fun communicated by Michael and the whole band. These guys are having fun and praising God, and the fun is contagious. Not only is the sound one of the best around, but it is recorded professionally, and the camera work matches any I've seen. The album includes most of his work, guest appearances and backup by Amy Grant (with probably the earliest live recording of Find A Way), Gary Chapman, Kathy Troccoli, Billy Sprague and White Heart's David Huff.The Gospel is presented strongly, superbly, and by some of His best talent in the Kingdom. It you can buy, beg, or borrow a VCR, get it.

Rich Mullins sings his praise to the Lord

One of Christian music's foremost songwriters, Rich Mullins, has produced a knockout collection of original material for his debut album LP. You may know his name from the by-lines of such songs as Amy Grant's "Sing Your Praise to the Lord" and Debby Boone's "O Come All Ye Faithful." If these ring a bell, or even if they don't, you need to hear what this guy has to say.

Rich's tyrics are personal and insightful — and do they say a lot! Highlights include "A Few Good Men," a pop-rocker that opens the A-side and emphasizes the importance of standing up for Christ in a

world that needs to know the difference. "Live Right," another snappy one, carries the theme farther with phrases like, "Live like you'll die tomorrow, die knowing / you'll live forever, live right." Pretty heavy? "Nothing But a Miracle" is both a testimony and praise for the love of God that can

expression of determination and defiance of the world and its system of values. The chorus:

Other songs include "Both Feet on the Ground," which addresses

being single from a personal pointof-view and "These Days," which illustrates a commitment to looking for the love of Christ in the midst of secular upheaval. "Save Me" closes the B-side with an emotional, determined attitude through a short, poignant prayer.

Other credits on the album belong to songwriters Pam Marle Hall and Wayne Kirkpatrick ("Wise Up") as well as vocalists Billy Crockett and Amy Grant. If you liked "Sing Your Praise," you should eat this one up!
