For every coin hidden away, the mint must make another to replace it.

Let's do our part, NNC students; convert your small coins into War Saving Stamps, or even into coins of a larger denomination, of which there is an ample supply.

Army Calls For Mountain Troops

Those who wish to volunteer before induction can still do so, no longer by enlistment, but by voluntary induction through their draft boards. The National Ski Association can still recommend special assignments, in advance, for men whose applications are approved.

Candidates need not be skiers or mountaineers. Applications of any young men who are merely firstclass raw material will be considered.

Of course men who have lived and worked in the mountains, such as rock climbers, trappers, packers, guides, prospectors, timber cruisers, are preferred, or good skiers who are physically fit for rigorous mountain training, but these are no longer available in the numbers required. In brief, the requirements are primarily an ardent desire to serve in the mountain forces, and the physical fitness obviously needed.

Young Appointed N.N.C. Caretaker

Announcement was made last week of the appointment of J. O. Young as caretaker and superintendent of student work at NNC. Mr. Young also installed the heating system now in use, and is thus well acquainted with the job for which he has been chosen. Northwest Nazarene college will take another progressive step next semester when, in compliance with government plans, it will open the doors of the college to high school seniors of specified standing.

In order to be eligible to begin college freshman work, high school students must have completed their junior year, be at least 17 years of age, and in the upper 50 per cent of their class. At the end of their freshman year in college they will be iven their high school diplomas. A new schedule is being mapped out for the courses to be taken by students who wish to speed up their education and get one or two years of college completed before they are called to active service.

Constitution of the Associated Student Body of Northwest Nazarene College

THE CONSTITUTION

Article I.—Name and Purpose Sec. 1. This organization shall be known as the Associated Students of the Northwest Nazarene College.

Sec. 2. The object of this organization will be to carry on student activities consistent with the standards of the Institution and to see that the Student Body is officially represented in dealing with outside organizations. All organizations not sponsored by administrative departments shall be subject to the Associated Students of Northwest Nazarene College.

Article II-Membership

Sec. 1. All students who are members of the College of Liberal Arts and all special departments thereof and the Academy and all departments thereof shall upon payment of the required student fee become members of the Associated Students of Northwest Nazarene College.

Article III—Officers; qualifications And Election of

Sec. 1. The officers of this organization shall consist of President, vice president, secretary, treasurer and sergeant-at-arms.

Sec. 2. The qualifications for the officers shall be as follows: President, vice president, and the treasurer shall have upper division standing in the College of Liberal Arts during tenure of office and shall have been in attendance at the college not less than one year previous to their election. The Secretary will be chosen at large. The sergeant-at-arms shall be elected from the Academy. All officers of this Association shall be Christians and of accredited class standing.

Sec. 3. Four weeks prior to the final examinations there shall be held the nomination and election of the Student-body Pres. The nomination and election shall be held in student body meetings, and all voting shall be done by ballot. The two members receiving the highest number of votes on the nominating ballot shall be considered candidates for presidency. There shall be a lapse of at least two days between the nomination and the election.

Sec. 4. Three weeks prior to the final examinations there shall be held a student body meeting for the purpose of nominating, according to Section 2, the Vice President, Secretary, Treasurer and Sergeant-at-arms for the coming year. The two nominees receiving the highest number of votes for each office shall be considered candidates for said office.

Sec. 5. All nominations shall be submitted to the Admin. Council and after having been approved by the same shall be posted. One week after nomination of officers, as in Section 4, a meeting shall be held to elect officers from declared nominees. A plurality shall elect.

are qualified. In the case of a vacancy in any office, except the presidency, arising from any cause, the nominee receiving the next highest vote shall fill the vacancy subect to the approval of the Associated Students. Upon the vacancy in the office of President, the Vice President shall assume the duties of the office of President, and follow the usual procedure in filling the vacancy in the Vice President's office. In the event of a vacancy in both the offices of President and Vice President, a special election shall be held at once, called by the Secretary, to proceed after the manner prescribed in Article III, Section 5.

Article IV .- Officers, Duties of

Sec. 1. The duties of the President shall be to preside at all sessions of the Association and also of the Student Council, hereinafter provided for, to announce the business in its proper order, to state and properly put all questions before the Associated Students or Council and decide all questions of order. He may, at his discretion, convene either the entire Associated Students of the Executive Council.

Sec. 2. The duty of the Vice President shall be to fill the office of President during his temporary absence.

Sec. 3. The duties of the Secretary shall be to keep a record of the proceedings of all the meetings both of the Associated Students and of the Student Council, and to keep on file all official documents of the Associated Students, including a copy of the constitution. The Secretary shall also take care of the sending of flowers to the sick in the student body and faculty.

Sec. 4. The duty of the Treasurer shall be to receive all funds of the Associated Students, and disburse the same on order of the Student Council signed by the President and Treasurer. He shall render, at the close of his term of office, a detailed report of the finances of the organization, which shall be attested by an auditing committee, outside the institution, appointed by the Student Council He shall deliver all property of the Associated Students in his care to his successor within one week after the inauguration.

Sec. 5. The duties of the Sergeant-at-Arms shall be to preserve order during all sessions of the Associated Students and the Executive Council. He shall also see that the flag is displayed daily, and properly care for it.

Article V-Student Council

Sec. 1. The council shall be composed of the officers of the Associated Student Body — President, Vice-President, Secretary, Treasurer, Sergeant-at-Arms—the graduate school representative, and the representative of each of the four colege classes. All council members with the exception of the freshmen representative shall have matriculated in the institution at least one year prior to their election, by ballot, and a majority shall adopt.

Sec. 4. The Student Council shall not pass any resolution which shall in any way infringe upon, supersede or nullify an act of the Associated Students.

Sec. 5. The Associated Students may act on any question, even if previously passed upon by the Student Council. The judgment of the Associated Students shall be regarded as final.

Article VI.—Publications

Sec. 1. The "Oasis" shall be the annual publication of the Associated Students of Northwest Nazarene College.

Sec. 2. The Student Council shall nominate two members of the Associated Students as candidates for the editorship of the "Oasis" for the following year. Upon approval of these names by the Administrative Council they shall be submitted to the Associated Students for election at the time of the election of President.

Sec. 3. The Student Council shall approve the "Oasis" staff as recommended by the editor subject to the approval of the Administrative Council. In the event of a vacancy in the office of editor the Executive Council shall have the power to appoint an editor, subject to the approval of the Administrative Council and the Associated Students.

Sec. 4. The "N. N. C. Crusader" shall be the bi-weekly publication of the Associated Students of Northwest Nazarene College.

Sec. 5. The Student Council shall nominate two members of the Associated Students as candidates for the editorship of the "N. N. C. Cruasder," for the following year. Upon approval of these names by the administratiive Council they shall be submitted to the Associated Students for election at the time of the election of President.

Sec. 6. The Student Council shall approve the "N. N. C. Crusader" staff as recommended by the editor subject to the approval of the Administrative Council. In the event of a vacancy in the office of editor, the Student Council shall have power to appoint an editor, Sec. 2B. The Student Council may amend the Constitution subject to the approval of the Administrative Council and the ratification by the Associated Students.

Sec. 3. The By-Laws of the constitution of the Associated Students of Northwest Nazarene College shall be adopted by the same procedure as followed for amendments stated in Article VI, Section 2 above.

BY-LAWS Article I.—Fees

Sec. 1. The fees of this organization shall be six dollars per semester for all students registered either in the College or Academy. These fees are to be collected by the business office of the Student Body before completion of registration. The fee of two dollars shall be required of all students registered for less than six hours. This amount is to be collected by the Treasurer before completion of registration.

Sec. 2. The fees shall be apportioned to the following organizations and funds: All classes in college and academy, the Athletic-Literary Societies, the Christian Workers' Band, the Spencerian Speech club, Intercollegiate Athletics, Oasis, Reserve Fund, Flower Fund, and the Associated Women Students, "N. N. C. Crusader," and the Men's club.

Article II.—Organizations

Sec. 1. The Athletic and Literary activities shall be carried on by four Athletic-Literary Societies. Namely, the Alpha Delta Phi, the Olympian, the Sigma Lamba Alpha and the Lamba Sigma Pi. The executives of each society shall be composed of President, Vice President, Secretary, Treasurer, Chairman of Program Committee, Men's and Women's Athletic Directors, two faculty sponsors and such minor offices as each society shall deem advisable. The officers of each society shall be elected at the beginning of each semester.

Sec. 2. The Presidents, Vice Presidents, Chairmen of the Program Committee, Athletic Directors, Faculty Sponsors, and the Athletic manager of the school shall compose the Athletic-Literary Council with the President of the College acting as Chairman.

Sec. 3. The Forensic activities of the Associated Students shall be conducted by the "Spencerian Speech Club" consisting of those interested in such activities and desiring to join. The officers of this club shall be President, Treasurer, Secretary, Debate Manager and Declamation Manager. The Debate Manager shall act as Vice President.

Sec. 4. All students interested in doing Christian work shall be considered members of the Christian Sec. 1. No student is allowed to succeed himself in a major office or in the capacity of President or Program Chairman of the Athletic-Literary Societies.

Sec. 2. No student shall be allowed to participate in intersociety intermural, and intercollegiate activities more than nine semesters.

Sec. 3. All student body officers shall at the time of their election be making at least a "C" average scholastically.

Sec. 4.. The system of limiting the number of offices one student may hold is as follows:

1. Students shall be allowed to earn a maximum of 10 points in one year.

RECOMENDATIONS OF TH	E

RECOMENDATIONS OF THE CONSTITUTION COMMITTEE

I. We recommend that Section 2, Article III, ELECTIONS, providing for the filing of all records of Student Body Elections in a permanent form by the Secretary of the Student Body be strictly observed. This duty has been badly neglected in the past, and is essential to the carrying out of Section 6, ARTICLE III, regarding the filling of vacancies in student body offices. II. The point system for limiting the offices which any student may hold at one time, given in Article IV of the By Laws, Sec. 4, has not been enforced. The observance of this point system is essential to the best interests of scholarship. We recommend and urge strongly that this point system be rigidly enforced. III. We recommend that a provision be added to the Constitution providing for the recall of any officer of the Associated Students who does not abide by the Constitution. In the past there have been times when the provisions of the Constitution have been neglected or set aside. At the present time the Associated Students have no way of being assured that the officer they elect will abide by the Constitution.

Sec. 6. The new officers shall be inaugurated at the last chapel service of the school year.

Sec. 7. At the beginning of the fall semester each class of the college department shall hold a meeting for the purpose of nominating two students to be candidates for representatives to the Executive Council. The two nominees receiving the highest number of votes in each class shall be considered candidates for representative to the Executive Council. There shall be a lapse of one week between the time of nomination and the election by the members of the student body.

Sec. 8. All officers of the Associated Students shall be elected for a term of one year. They shall hold office until their successors Sec. 2. Except as otherwise specified, the Student Council shall supervise and have full charge of all the affairs of the Associated Students.

Sec. 3a. The Student Council shall have charge of the apportionment of all student body monies, subject to the approval of the Administrative Council and the Associated Students.

Sec. 3b. The Student Council shall authorize the Treasurer to submit the proposed budget for the current semester at a duly called meeting of the Associated Students for their approval. Voting shall be subject to the approval of the Administrative Council and the Associated Students.

Article VII.—Ratification, Amendments andBy-Laws

Sec. 1. This constitution shall take effect when it has passed the Student Council and the Administrative Council, and has been ratified by a two-thirds vote of the Associated Students.

Sec. 2A. Amendments or alterations to this constitution may be submitted to the Student Council in writing signed by ten per cent of the members of the Associated Students of the Northwest Nazarene College. Said amendment shall be submitted to the Administrative Council and if approved shall be read before a meeting of the Associated Students. Within one week another meeting shall be called for the purpose of voting upon the proposal. A two-thirds vote shall be required to pass any amendment.

Worker's Band. The officers of the band shall be President, Vice President, and Secretary-Treasurer. The officers for the current year shall be elected not less than two weeks before the end of the previous year. Article III.—Elections

Sec. 1. At the time of the student body election the President of the Associated Students shall appoint a Board of Tellers consisting of six members to receive, count, and record the returns of the ballots.

Sec. 2. A numerical record of each student body election shall be made by the Board of Tellers and given to the Secretary of the Associated Students for permanent filing. Those records shall be available for inspection at the request of any member of the Associated Students.

Sec. 3. All elections shall be by ballot.
